If a public comment speaker wishes to speak on more than one agenda item, please indicate which items on the online form. Public comments are limited to 3 minutes each, and the Chair may limit this time if reasonable under the circumstances.

2. <u>In-person Meeting Participation</u>: Complete an online speaker card at the following website: <u>www.cityofpasadena.net/planning/public-comment</u>

After submitting a public speaker card, members of the public may attend the meeting in-person by coming to the Pasadena City Council Chamber, Room S249 at City Hall at the date and start-time of the posted meeting.

Alternatively, a member of the public may attend the meeting in-person and complete a physical speaker card, available at the meeting, and provide it to the Recording Secretary.

<u>Virtual Meeting Participation</u>: For virtual participants, you may attend by connecting to the meeting using a computer, other electronic device, or by telephone. Please review the agenda to identify the published start time for the meeting and connect to the meeting just prior to, or at the start of the meeting.

To participate in public comment for an item and to be recognized to speak, it is required that the speaker login to the meeting using the same name or telephone number used on the Speaker Card form. ## A. CENTRAL DISTRICT SPECIFIC PLAN

Staff will present a recommendation to update the Central District Specific Plan (proposed CDSP), requiring the following approvals: General Plan Map Amendment, Specific Plan Amendment, and Zoning Code Map and Text Amendments. The CDSP is the fourth specific plan to be updated as part of the General Plan Implementation Program. The update will implement General Plan Land Use policies and a refined plan vision, goals, policies, permitted uses, residential densities, buildable area, and other development and design standards to shape the built environment for the CDSP area. Amendments to the Zoning Code Text include technical changes in the previously adopted South Fair Oaks Specific Plan for internal consistency.

It is recommended that the Planning Commission:

- 1) Recommend that the City Council consider an Addendum to the 2015 Pasadena General Plan Environmental Impact Report (EIR), along with the EIR, and find that the Addendum properly discloses only minor technical changes or additions to the EIR, and none of the conditions triggering a subsequent or supplemental EIR are present, as set forth in State CEQA Guidelines Section 15164; and
- 2) Recommend that the City Council make the Findings for Approval for the General Plan Map Amendment, Specific Plan Amendment, and

Zoning Code Map and Text Amendments and approve the proposed CDSP.
